US Water Polo – US Leagues memberships is required for participation in the NSSWPL League. There is a \$5 NSSWPL participation fee for each player in the league. This Fee covers the cost of Referees, Administration and Champion Tournaments. Each team will submit final rosters and NSSWPL Fee Payment on 7/1/2009

Please read this form carefully and be aware that in signing up and participating in this program, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program (including transportation services/vehicle operation, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this program, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program against the Naperville Subdivision Summer Water Polo League, the Naperville Park District, the Team indicated herein, officials, coaches administrators, agents, volunteers, and employees (hereinafter collectively referred to as League).

I do hereby fully release and forever discharge the League from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this program.

Warning of Risk: Recreational programs are intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when participating in any recreational program. Understandably, not all hazards and dangers can be foreseen.
