SECOND AMENDMENT TO DECLARATION OF [CONDITIONS, RESTRICTIONS AND RESERVATIONS](#) AFFECTING HOBSON WEST

This Amendment to the Declaration of [Conditions, Restrictions and Reservations](#) Affecting Hobson West, recorded at the DuPage County Recorder's Office on May 4, 1977, as Document Number R77-32543 and as amended from time to time, is made this March 8, 2007, pursuant to a Resolution adopted by the Board of Directors of Hobson West Community Association of Naperville, Inc., an Illinois Not For Profit Corporation, as authorized by a vote of not less than two thirds of the voting members present at a Special Meeting of the Shareholders of said Corporation, and executed by the Directors and Officers of said Corporation pursuant to said Resolution.

BE IT KNOWN that Article III, Hobson West Community Association, Paragraph 13 (F.) of the Declaration of [Conditions, Restrictions and Reservations](#) Affecting Hobson West, recorded at the DuPage County Recorder's Office on May 4, 1977, as Document Number R77-32543 and as amended from time to time shall be amended by deleting the currently recorded language in its entirety and replacing it with a new Article III, Hobson West Community Association, Paragraph 13 (F.) and said new paragraph shall read as follows:

F. In the event of failure of any owner to pay any assessment on or before thirty (30) days following the scheduled due date of any such assessment, then the assessment shall become delinquent. Such delinquent assessment, along with any costs and/or fees hereinafter provided, shall bear interest from the original due date until paid at the highest interest rate allowed by the law of Illinois or twenty-four percent (24%) per year, whichever is less. Any delinquent assessment shall become a continuing lien in favor of the Association on each lot against which such assessment is levied, and such lien shall secure payment of any and all amounts due hereunder. When delinquent, payment of all amounts due may thereafter be enforced against the owner personally through an action at law, or through foreclosure of said lien. In the event a judgment is obtained against the owner, such judgment shall include all costs, expenses, attorneys fees, and interest set forth herein. When any assessment becomes delinquent, the Association may, at its discretion, file a certificate of non-payment and/or claim for lien with the DuPage County Recorder of Deeds office. In the event any such certificate of non-payment and/or claim for lien is filed with the DuPage County Recorder of Deeds office the costs of said filing shall be added to the principal amount due. Any and all expenses and/or costs incurred by the Association in collecting any delinquent assessment, including but not limited to attorney fees, title search fees, recording charges, and investigative charges, shall be added to the principal amount due and shall bear interest as set forth hereinabove.

AND

BE IT KNOWN that Article VI, Architectural Controls of the Declaration of [Conditions, Restrictions and Reservations](#) Affecting Hobson West, recorded at the DuPage County Recorder's

Office on May 4, 1977, as Document Number R77-32543 and as amended from time to time shall be amended by adding two paragraphs to said Article VI and said new paragraphs shall read as follows:

Members shall submit plans, specifications and other material identified above not less than thirty (30) days prior to the issuance by the City of Naperville of final building permits. Members of the Corporation may be censured, fined up to \$100.00 per day that any violation hereunder exists or continues, and/or have privileges of membership suspended for any violation of this Article VI. Discipline shall be by affirmative vote of the Board of Directors or such other body as designated by the Board of Directors; provided that a statement of the charges shall have been delivered by certified mail, overnight commercial delivery service, or by hand or other forms of delivery to the last recorded address of the member at least five (5) days before final action is to be taken. This statement shall be accompanied by a notice of the time and place of the meeting of the Board of Directors or such other body as designated by the Board of Directors at which the charges shall be considered, and the member shall have the opportunity to appear in person and to be represented by legal counsel before action is taken. Nothing herein shall affect any right or decision by the Board to assert any remedy either at law or in equity which is otherwise allowed under these Conditions, Restrictions and Reservations.

In the event that the Board of Directors shall issue any fine hereunder, said fine shall constitute a lien upon the real estate owned by the Member. Said lien may be perfected and enforced in the same manner provided in Article III, Hobson West Community Association, Paragraph 13 (F.), as amended from time to time. Any unpaid amount hereunder shall bear interest and be enforceable in the same manner provided in Article III, Hobson West Community Association, Paragraph 13 (F.), as amended from time to time.
